Delivery Period: Delivery period shall be 90 days from date of receipt of release order / CAT-A issuance, whichever is later. The delivery period for a quantity of up to 500 Nos. shall be 90 days from the date of issuance of the RO or GTP drawing approval, whichever is later. For new / fresh RO to be issued for any quantity within the existing RO delivery period, the delivery period shall be mutually agreed upon between the BA and the DISCOM. DISCOMs may also plan delivery in a staggered manner based on business requirements, as per the mutual agreement. In such cases, a month-wise delivery plan along with delivery date will be specified in the SCC of the RO.

All other terms and conditions of the above tender shall remain unaltered.
